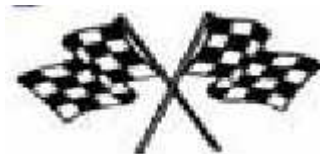
Welcome to all our new members and we hope to see you again at an upcoming event.

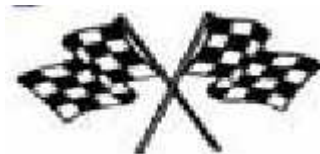

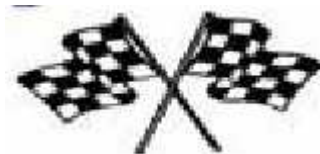

## 2012 End of Summer Fun Run

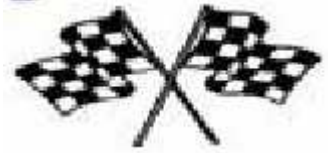

## QUAKER STEAK & LUBE

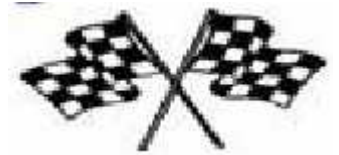
